V. **Women in Ministry Proposal – DEXCOM** (For complete details on the DEXCOM recommendations please see their handout and or information.)

a. **Recommendation 1**

All licensed female provisional workers who decide to pursue Consecration and Ordination in the Hmong District shall agree to abide by Hmong District’s conviction that the title “Reverend” confers spiritual and ecclesiastical authority within a Hmong District Church that has been reserved for only male clergy members. **It is recommended that: “The Hmong District holds biblically that a woman may be licensed to serve in ministry but not with the title “Pastor” and/or “Reverend.” An official licensed female worker serving and/or pursuing consecration and ordination with the Hmong District, upon her completion, will not be conferred with the title “Reverend” but the title “Miss” or “Mrs.” with Consecrated Woman Ministry (CWM) after her name.”**

IV. Women in Ministry Proposal – DEXCOM

- a. Refer to DEXCOM recommendations for the complete document.
- b. Recommendation 1
 - i. It is recommended that: **“The Hmong District holds biblically that a woman may be licensed to serve in ministry but not with the title “Pastor” and/or “Reverend.” An official licensed female worker serving and/or pursuing consecration and ordination with the Hmong District, upon her completion, will not be conferred with the title “Reverend” but the title “Miss” or “Mrs.” with Consecrated Woman Ministry (CWM) after her name.”**
 - ii. Recommendation 1 was open for debate and discussion. Many points of clarification were asked from the floor to the Moderator Rev. Xeng Yang and C&MA Representative Dr. Rosilio Roman. After considerable discussion, Recommendation 1 was moved to close debate and was passed.
 - iii. Recommendation 1 was moved to a vote and was adopted.

- c. Recommendation 2
 - i. It is recommended that: **Each local church of the Hmong District should hold the Hmong District's biblical understanding that a woman may be licensed to serve with a different title other than "Pastor" and/or "Reverend" as allowed under the C&MA Manual Section B1.4.**
 - ii. Recommendation 2 was open for debate and discussion. Many points of clarification were asked from the floor to the Moderator Rev. Xeng Yang and C&MA Representative Dr. Rosilio Roman.
 - iii. The floor made the following amendment to the recommendation and was seconded:
 - 1. "Each local church of the Hmong District ~~should~~ **must** hold the Hmong District's biblical understanding that a woman may be licensed to serve with a different title other than "Pastor" and/or "Reverend" as allowed under the C&MA Manual Section B1.4."
 - iv. The amendment to the recommendation passed, Recommendation 2 now reads as follows:
 - 1. "Each local church of the Hmong District **must** hold the Hmong District's biblical understanding that a woman may be licensed to serve with a different title other than "Pastor" and/or "Reverend" as allowed under the C&MA Manual Section B1.4."
 - v. Recommendation 2 was moved to a vote and was adopted.
- d. The DEXCOM's report on Women in Ministry was adopted as a whole.

 - 1. (OLD) 5. District Conference Search Committee
 - a. ~~The District Executive Committee shall determine the location of the District Annual Conference two (2) years before the conference and shall appoint three (3) members who live close to that city along with the District Superintendent to find the venue and prepare the conference.~~
 - 2. (NEW) 5. District Conference Search Committee
 - a. **The District Executive Committee shall determine the location of the annual District conference two (2) years before the conference and the logistics be assigned to the conference committee. The conference committee shall consist of DS plus three (3) members appointed by DEXCOM.**

- 3. Recommendation 1 has been adopted.
- ii. Recommendation 2: Motion to remove (Article IV, Section A-2-c-2)
 - ~~1. Article IV, Section A-2-c-2~~
 - ~~a. The pastoral staff shall agree to stay with the local church for a period of one year after the pastoral staff has been granted sabbatical leave. If the pastoral staff moves to another location due to emergency or special situation, the pastoral staff shall pay back to the local church all the financial benefits received during the time he/she was on sabbatical by DEXCOM.~~
 - 2. Recommendation 2 has been adopted.
